## FULL PARK PLACE TECHNOLOGIES PRIVACY POLICY

Thank you for visiting our Service, which is owned or operated by Park Place Technologies, LLC (“**Park Place Technologies**”). This Privacy Policy will provide you with information as to how Park Place Technologies collects, uses, and shares information about you, including the choices Park Place Technologies offers with respect to that information, and applies to your use of any Service, regardless of how you access or use it. It does not apply to Park Place Technologies' data collection activities offline or otherwise outside of the Service (unless otherwise stated below or at the time of collection). For certain Services, or if you access the Service from certain non-U.S. jurisdictions, there may be additional notices about information practices and choices. Please read those additional privacy disclosures to understand how they apply to you.

By visiting or otherwise using the Service, you agree to the Service's Terms of Use and consent to Park Place Technologies' data collection, use, and disclosure practices, and other activities as described in this Privacy Policy, and any additional privacy statements that may be posted on an applicable part of the Service. If you do not agree and consent, please discontinue use of the Service, and uninstall Service downloads and applications.

### 1. INFORMATION WE COLLECT.

**A. Information about You that You Provide.** Park Place Technologies, and/or its Service Providers (defined below), may collect information you provide directly to Park Place Technologies and/or its Service Providers via the Service. For example, Park Place Technologies collects information when you use or register for the Service, subscribe to notifications, post on the Service, participate in promotional activities, or

communicate or transact through the Service. In addition, when you interact with Third-Party Services (defined below), you may be able to provide information to those third parties. For more information on Third-Party Services' data collection and practices, read Section 5. For more information on Service Provider data collection and practices, review Section 3.

Information Park Place Technologies, its Service Providers and/or Third-Party Services may collect may include: (1) personally identifiable information, which is information that identifies you personally, such as your first and last name, e-mail address, phone number, address, and full payment account number (“**Personal Information**”); and (2) demographic information, such as your gender, age, zip code, interests, and recent and upcoming purchases (“**Demographic Information**”). Except to the extent required by applicable law, Demographic Information is “**non-Personal Information**” (i.e., data that is not Personal Information under this Privacy Policy). In addition, Personal Information, including, without limitation, Park Place Technologies-Collected PI (defined below), once “De-identified” (i.e., the removal or modification of the personally identifiable elements, or the extraction non-personally identifiable elements including through anonymization, pseudonymization, and hashing) is also non-Personal Information and may be used and shared without obligation to you, except as prohibited by applicable law. However, we do not make assurances that De-identified data is not capable of re-identification. To the extent any non-Personal Information is combined by or on behalf of Park Place Technologies with Personal Information Park Place Technologies itself collects directly from you on the Service (“**Park Place Technologies-Collected PI**”), Park Place Technologies will treat the combined data as Park Place Technologies-Collected PI under this Privacy Policy.

**B. Information Collected Automatically.** Park Place Technologies, its Service Providers, and/or Third-Party Services may also automatically collect certain information about you when you access or use the Service (“**Usage Information**”). Usage Information may include IP address, device identifier, browser type, operating system, information about your use of the Service, and data regarding network connected hardware (e.g., computer or mobile device). Except to the extent required by applicable law, or to the extent Usage Information is combined by or on behalf of Park Place Technologies with Park Place Technologies-Collected PI, Park Place Technologies does not consider Usage Information (including, without limitation, unique device identifiers) to be Personal Information or Park Place Technologies-Collected PI. For more information on Third-Party Services' data collection and practices, read Section 5. For more information on Service Provider data collection and practices, review Section 3. For information on choices some of these third parties may offer you regarding automated data collection, review Section 10.

The methods that may be used on the Service to collect Usage Information include:

- **Log Information:** Log information is data about your use of the Service, such as IP address, browser type, internet service provider, referring/exit pages, operating system, date/time stamps, and related data, and may be stored in log files.
- **Information Collected by Cookies and Other Tracking Technologies:** Cookies, web beacons (also known as “tracking pixels”), embedded scripts, location-identifying technologies, fingerprinting, device recognition technologies, in-app tracking methods and other tracking technologies now and hereafter developed (“**Tracking Technologies**”) may be used to collect information about interactions with the Service or e-mails, including information about your browsing and purchasing behavior.
- **Cookies**

A cookie is a small text file that is stored on a user's device, which may be session ID cookies or tracking cookies. Session cookies make it easier for you to navigate the Service and expire when you close your browser. Tracking cookies remain longer and help in understanding how you use the Service, and enhance your user experience. Cookies may remain on your hard drive for an extended period of time. If you use your browser's method of blocking or removing

cookies, some but not all types of cookies may be deleted and/or blocked and as a result some features and functionalities of the Service may not work. A Flash cookie (or locally shared object) is a data file which may be placed on a device via the Adobe Flash plug-in that may be built-in to or downloaded by you to your device. HTML5 cookies can be programmed through HTML5 local storage. Flash cookies and HTML5 cookies are locally stored on your device other than in the browser and browser settings won't control them. The Service may associate some or all of these types of cookies with your devices.

- **Web Beacons (“Tracking Pixels”)**

Web beacons are small graphic images, also known as “internet tags” or “clear gifs,” embedded in web pages and e-mail messages. Web beacons may be used, without limitation, to count the number of visitors to the Service, to monitor how users navigate the Service, and to count content views.

- **Embedded Scripts**

An embedded script is programming code designed to collect information about your interactions with the Service. It is temporarily downloaded onto your computer from Park Place Technologies’ web server, or from a third party with which Park Place Technologies works, and is active only while you are connected to the Service, and deleted or deactivated thereafter.

- **Location-identifying Technologies**

GPS (global positioning systems) software, geo-filtering and other location-aware technologies locate (sometimes precisely) you, or make assumptions about your location, for purposes such as verifying your location and delivering or restricting content based on your location. If you have enabled GPS or use other location-based features on the Service, your device location may be tracked.

- **Fingerprinting**

Collection and analysis of information from your device, such as, without limitation, your operating system, plug-ins, system fonts, and other data, for purposes of identification and/or tracking.

- **Device Recognition Technologies**

Technologies, including application of statistical probability to data sets, as well as linking a common unique identifier to different device use (e.g., Facebook ID), which attempt to recognize or make assumptions about users and devices (e.g., that a user of multiple devices is the same user or household) (“**Cross-device Data**”).

- **In-App Tracking Methods**

There are a variety of Tracking Technologies that may be included in mobile applications, and these are not browser-based like cookies and cannot be controlled by browser settings. Some use device identifier, or other identifiers such as “Ad IDs” to associate app user activity to a particular app and to track user activity across apps and/or devices.

Some information about your use of the Service and certain third-party services may be collected using Tracking Technologies across time and services, and used by Park Place Technologies and third parties for purposes such as to associate different devices you use, and deliver relevant ads and/or other content to you on the Service and certain third-party services. See Section 10 regarding certain choices regarding these activities.

Park Place Technologies is giving you notice of the Tracking Technologies and your choices regarding them explained in Section 10 so that your consent to encountering them is meaningfully informed.

**C. Information Park Place Technologies Collects From Other Sources.** Park Place Technologies may also obtain information about you from other sources, including Service Providers and Third-Party Services, and combine that with Park Place Technologies-Collected PI. Notwithstanding anything to the contrary, except to the extent such data combined by or on behalf of Park Place Technologies with Park Place Technologies-Collected PI, this Privacy Policy is not intended to limit Park Place Technologies' activities regarding such third-party-sourced, or non-Service-sourced, information (including Personal Information), and such data will only be treated as Park Place Technologies-Collected PI to the extent it is combined with Park Place Technologies-Collected PI. Park Place Technologies is not responsible or liable for the accuracy of the information provided by third parties or for third party policies or practices.

## **2. HOW WE USE THE INFORMATION WE OBTAIN.**

Park Place Technologies may use information about you, including Park Place Technologies-Collected PI and other Personal Information, for any purposes not inconsistent with Park Place Technologies' statements under this Privacy Policy, or otherwise made by us in writing at the point of collection, and not prohibited by applicable law, including, without limitation, the following:

- Allow you to participate in the features we offer on the Service;
- Facilitate, manage, personalize, and improve your online experience;
- Process your registration, manage your account and/or upload your User Generated Content (“UGC”). (For more information on how UGC is treated under the Service's Terms of Use, read Section 2 of the Terms of Use. For more on the public nature of UGC, see Section 4);
- Transact with you, provide services or information you request, respond to your comments, questions and requests, serve you content and/or advertising, and send you notices;
- Park Place Technologies and Affiliates' marketing and other purposes which you consent thereto by providing your Personal Information;
- Improve the Service and for any other internal business purposes;
- Tailor our content, advertisements, and offers;
- Fulfill other purposes disclosed at the time you provide Personal Information or otherwise where we are legally permitted or are required to do so;
- Determine your location and manage digital content rights (*e.g.*, territory restrictions); and
- Prevent and address fraud, breach of policies or terms, and threats or harm.

### 3. INFORMATION WE SHARE WITH THIRD PARTIES.

Subject to applicable law, Park Place Technologies may share non-Personal Information, and Personal Information that is not deemed Park Place Technologies-Collected PI hereunder (provided that Park Place Technologies is aware of no restrictions of Park Place Technologies' use, if any), with third parties or Park Place Technologies and their affiliates (“**Affiliates**”) for any purpose. Subject to applicable law, Park Place Technologies' sharing of Park Place Technologies-Collected PI is, however, subject to the following:

- Marketing: Subject to your communications choices explained in Section 10.D, we may use your Personal Information to send you marketing communications. We will not share your Personal Information with third parties, other than Affiliates, for third parties' marketing purposes unless you opt-in to such sharing and will discontinue sharing if you opt-out (see Section 10.D), except in connection with Corporate Transactions (defined below), or if you consent to such sharing via a third party interaction described in the next bullet point.
- Your Disclosure or Consent: As more fully described in Section 4 (Information You Disclose Publicly or to Others) and Section 5 (Third-Party Content, Third-Party Services, Social Features, Advertising and Analytics), your activities on the Service may, by their nature, result in the sharing of your Park Place Technologies-Collected Personal Information (as well as your other Personal Information and your non-Personal Information) with third parties and by engaging in these activities you consent to that and further sharing and disclosure to third parties. Such third party data receipt and collection is subject to the privacy and business practices of that third party, not Park Place Technologies.

Park Place Technologies may also share any information about you (including, without limitation, Park Place Technologies-Collected PI) for any purposes not inconsistent with this Privacy Policy, or our written statements at the point of collection, and otherwise not prohibited by applicable law, including, without limitation:

- Park Place Technologies' agents, vendors, consultants, and other service providers (collectively “**Service Providers**”) may receive, or be given access to your information, including, without limitation, Personal Information, Demographic Information, and Usage Information, in connection with their work on Park Place Technologies' behalf, provided however, Park Place Technologies does not authorize its Service Providers to use Park Place Technologies-Collected PI provided by Park Place Technologies to the Service Providers to send you direct marketing messages other than related to Park Place Technologies and Affiliates absent your consent. For more information on choices Service Providers may offer you, read Section 10.
- To comply with the law, law enforcement or other legal process, and in response to a government request; and
- If Park Place Technologies believes your actions are inconsistent with Park Place Technologies' terms of use, user agreements, applicable terms or policies, or to protect the rights, property, life, health, security and safety of Park Place Technologies, the Service or its users, or any third party.

In addition, Park Place Technologies may share your Park Place Technologies-Collected Personal Information (as well as your other Personal Information and your non-Personal Information), in connection with or during negotiations of any proposed or actual financing of our business, or merger, purchase, sale, joint venture, or any other type of acquisition or business combination of all or any portion of Park Place Technologies assets, or transfer of all or a portion of Park Place Technologies' business to another company, whether as a going concern or as part of bankruptcy, liquidation, or similar proceeding (“**Corporate Transactions**”).

In conjunction with laws and regulations enforced by the Equal Employment Opportunity Commission (“**EEOC**”), the Office of Federal Contract Compliance Programs (“**OFCCP**”) and similar state and local regulatory agencies, we may ask you to provide us with self-identifying information (such as veteran status, gender and ethnicity). Providing such self-identifying information is voluntary, but if you do provide us with such information, we may submit that information, to the EEOC, the OFCCP and similar state and local regulatory agencies or otherwise use or disclose it for business-related purposes, including, without limitation, responding to information requests, fulfilling regulatory reporting requirements and defending against employment related complaints.

#### **4. INFORMATION YOU DISCLOSE PUBLICLY OR TO OTHERS.**

The Service may permit you to post or submit UGC including, without limitation, written content, user profiles, audio or visual recordings, computer graphics, pictures, data, or other content, including Personal Information. If you choose to submit UGC to any public area of the Service, your UGC will be considered “public” and will be accessible by anyone, including Park Place Technologies. Notwithstanding anything to the contrary, unless otherwise explicitly agreed by us, Personal Information included in UGC is not subject to Park Place Technologies’ usage or sharing limitations, or other obligations, regarding Park Place Technologies- Collected PI or other Personal Information under this Privacy Policy or otherwise, and may be used and shared by Park Place Technologies and third parties to the fullest extent not prohibited by applicable law. Park Place Technologies encourages you to exercise caution when making decisions about what you disclose in such public areas. For more information on how UGC is treated under the Service’s Terms of Use, read Section 2 of the Terms of Use.

Additionally, the Service may offer you the option to send a communication to a friend or other contact. If so, Park Place Technologies relies on you to only send to people that have given you permission to do so. The recipient’s Personal Information you provide (*e.g.*, name, e-mail address) will be used to facilitate the communication, but not used by Park Place Technologies for any other marketing purpose unless Park Place Technologies obtains consent from that person. Your contact information and message may be included in the communication.

#### **5. THIRD-PARTY CONTENT, THIRD-PARTY SERVICES, SOCIAL FEATURES, ADVERTISING AND ANALYTICS.**

The Service may include hyperlinks to, or include on or in connection with, the Service (*e.g.*, apps and plug-ins), websites, locations, platforms, applications or services operated by third parties (“**Third-Party Service(s)**”). These Third-Party Services may use their own cookies, web beacons, and other Tracking Technology to independently collect information about you and may solicit Personal Information from you.

Certain functionalities on the Service permit interactions that you initiate between the Service and certain Third-Party Services, such as third party social networks (“**Social Features**”). Examples of Social Features include: enabling you to send content such as contacts and photos between the Service and a Third-Party Service; “liking” or “sharing” Park Place Technologies’ content; logging in to the Service using your Third-Party Service account (*e.g.*, using Facebook Connect to sign-in to the Service); and to otherwise connect the Service to a Third-Party Service (*e.g.*, to pull or push information to or from the Service). If you use Social Features, and potentially other Third-Party Services, information you post or provide access to may be publicly displayed on the Service (see Section 4) or by the Third-Party Service that you use. Similarly, if you post information on a third-party service that references the Service (*e.g.*, by using a hashtag associated with Park Place Technologies or other Park Place Technologies Affiliates in a tweet or status update), your post may be used on or in connection with the Service or otherwise by Park Place Technologies and Park Place Technologies Affiliates. Also, both Park Place Technologies and the third party may have access to certain information about you and your use of the Service and any Third-Party Service.



Park Place Technologies may engage and work with Service Providers and other third parties to serve advertisements on the Service and/or on third-party services. Some of these ads may be tailored to your interest based on your browsing of the Service and elsewhere on the internet, sometimes referred to as “interest-based advertising” and “online behavioral advertising” (“**Interest-based Advertising**”), which may include sending you an ad on a third party service after you have left the Service (i.e., “retargeting”).

Park Place Technologies may use Google Analytics or other Service Providers for analytics services. These analytics services may use cookies and other Tracking Technologies to help Park Place Technologies analyze Service users and how they use the Service. Information generated by these services (e.g., your IP address and other Usage Information) may be transmitted to and stored by these Service Providers on servers in the U.S. (or elsewhere) and these Service Providers may use this information for purposes such as evaluating your use of the Service, compiling statistic reports on the Service’s activity, and providing other services relating to Service activity and other internet usage.

Except to the extent we combine information we receive from Service Providers, Third-Party Services, or other third parties with Park Place Technologies-Collected PI, in which case Park Place Technologies will treat the combined information as Park Place Technologies-Collected PI under this Privacy Policy (see Section 1.C), data obtained by Park Place Technologies from a third party, even in association with the Service, is not subject to Park Place Technologies’ limitations regarding Park Place Technologies-Collected PI under this Privacy Policy, however such data remains subject to any restrictions imposed on Park Place Technologies by the third party, if any. Otherwise, the information collected, stored, and shared by third parties remains subject to their privacy policies and practices, including whether they continue to share information with Park Place Technologies, the types of information shared, and your choices on what is visible to others on Third-Party Services.

Park Place Technologies is not responsible for, and makes no representations regarding, the policies or business practices of any third parties, including, without limitation, analytics Service Providers and Third-Party Services associated with the Service, and encourages you to familiarize yourself with and consult their privacy policies and terms of use. See Section 10 for more on certain choices offered by some third parties regarding their data collection and use, including regarding Interest-based Advertising and analytics.

## **6. DATA SECURITY AND MONITORING.**

Park Place Technologies takes reasonable measures to protect Park Place Technologies-Collected PI (excluding public UGC) from loss, theft, misuse and unauthorized access, disclosure, alteration, and destruction. Nevertheless, transmission via the internet and online digital storage are not completely secure and Park Place Technologies does not guarantee the security of your information collected through the Service.

To help protect you and others, Park Place Technologies and its Service Providers may (but make no commitment to) monitor use of the Service, and may collect and use related information including Park Place Technologies-Collected PI and other Personal Information for all purposes not prohibited by applicable law or inconsistent with this Privacy Policy, including, without limitation, to identify fraudulent activities and transactions; prevent abuse of and investigate and/or seek prosecution for any potential threats to or misuse of the Service; ensure compliance with the Terms of Use and this Privacy Policy; investigate violations of or enforce these agreements; and otherwise to protect the rights and property of Park Place Technologies, Affiliates, third parties, and other users. Monitoring may result in the collection, recording, and analysis of online activity or communications through our Service. If you do not consent to these conditions, you must discontinue your use of the Service.

## **7. INTERNATIONAL TRANSFER.**

Park Place Technologies is based in the U.S. and the information Park Place Technologies and its Service Providers collect is governed by U.S. law, except as otherwise required by applicable law. If you are accessing the Service from outside of the U.S., please be aware that information collected through the Service may be transferred to, processed, stored, and used in the U.S. data protection laws in the U.S. may be different from those of your country of residence. Your use of the Service or provision of any information therefore constitutes your consent to the transfer to and from, processing, usage, sharing, and storage of your information, including Personal Information, in the U.S. as set forth in this Privacy Policy; provided, however that if you are accessing the Service from certain jurisdictions different terms, conditions or practices apply to your use of the Service. Please contact us at [dataprivacy@parkplacetech.com](mailto:dataprivacy@parkplacetech.com) to see if this applies to you.

## **8. CHILDREN'S PRIVACY.**

The Service is intended for a general audience and not directed to children less than 13 years of age. Park Place Technologies does not intend to collect personal information as defined by the U.S. Children's Privacy Protection Act ("COPPA") ("**Children's Personal Information**") in a manner that is not permitted by COPPA. If we obtain knowledge that we have collected Children's Personal Information in a manner not permitted by COPPA, we will remove such data to the extent required by COPPA.

## **9. ACCESSING AND CHANGING INFORMATION.**

Park Place Technologies may provide web pages or other mechanisms allowing you to delete, correct, or update some of the Park Place Technologies-Collected PI, and potentially certain other information about you (e.g., profile and account information). In addition, you can contact us at [support@parkplacetech.com](mailto:support@parkplacetech.com) to discuss your options regarding accessing, changing and deleting your Personal Information. To the extent permitted by applicable law, there may be a change for doing so unless you make changes yourself by means of your account tools. Park Place Technologies will make good faith efforts to make requested changes in Park Place Technologies' then-active databases as soon as practicable, but it is not always possible to completely change, remove or delete all of your information or public postings from Park Place Technologies' databases) and residual and/or cached data may remain archived thereafter. Further, we reserve the right to retain data (a) as required by applicable law; and (b) for so long as reasonably necessary to fulfill the purposes for which the data is retained except to the extent prohibited by applicable law. Certain international users may also have certain additional privacy rights detailed in Section 7.

## **10. CHOICES: TRACKING AND COMMUNICATIONS OPTIONS.**

**A. Tracking Technologies Generally.** Regular cookies may generally be disabled or removed by tools available as part of most commercial browsers, and in some instances blocked in the future by selecting certain settings. Browsers offer different functionalities and options so you may need to set them separately. Also, tools from commercial browsers may not be effective with regard to Flash cookies (also known as locally shared objects), HTML5 cookies, or other Tracking Technologies.
