

## Cookie Policy

This document explains the manner in which cookies, and similar tracking technologies, are used on Park Place Technologies' website, online customer portal and related services (all together the "**Website**"). It should be read in combination with the [Website Privacy Policy](#), as any personal data captured on Website users through these technologies will be handled in accordance with the principles and terms set out in that Policy.

### 1. General Information

This Website uses cookies. Cookies are small text files that the sites visited send to you and store on your computer or mobile device, and which will be returned to these same sites on each new visit. Thanks to these cookies, the Website remembers your actions and preferences (for example connection data, preferred language, font dimensions, other display settings, etc.) so that you do not have to need to specify them again when you return to the Website or consult another page on the same Website.

Cookies are used for electronic authentication, session monitoring and the storage of information on the activities of users visiting the Website. They may also contain a unique identifier allowing a system to monitor your browsing activities on the Website, for statistical or advertising purposes. When you visit a site, you may also receive cookies on your computer or mobile device from other sites or servers (third-party cookies). Certain operations may be impossible to perform without the use of cookies, which in some cases are technically necessary for the proper functioning of the Website.

There are different types of cookies and similar tracking tools (such as, but not limited to, web beacons, pixels, fingerprinting, etc.), also depending on their characteristics and functions, the duration of storage on your computer or mobile device.

For the purposes referred to in this Policy, any reference to cookies also refers to similar tracking tools.

Session cookies are automatically deleted when you close your browser, while persistent cookies remain on your device until a preprogrammed expiration date.

Prior explicit consent is not required for "strictly necessary cookies", i.e., those used for the sole purpose of carrying out the transmission of a communication over an electronic communications network, or as strictly necessary to provide a service explicitly requested by the user. In other words, cookies which are indispensable for the operation of the Website or to perform tasks requested by the user do not need your prior consent to be installed. On the other hand, "non-essential cookies" – i.e., cookies used to help Park Place Technologies to improve the Website by collecting and reporting information on how the users use it, to create users' profiles and to send targeted advertisements in line with the preferences revealed by users while browsing websites – require your specific consent.

Use of "non-essential cookies" may imply the "sale" or "sharing" of Personal Data under certain US privacy laws, including in California.

This website uses the Google Tag Manager, a service provided by Google Inc. (<https://www.google.de/intl/de/about/>, 1600 Amphitheatre Parkway, Mountain View, CA 94043, USA; hereinafter "**Google**"). Google Tag Manager is a solution that allows us to manage our Website tags and cookies through a single interface. The Google Tag Manager itself (which implements the tags) is a cookieless domain and does not collect any personal data. The tool triggers other tags and cookies, which may collect data. Google Tag Manager does not access this data. If cookies or tags have been deactivated (see below) at the domain or cookie level, it will remain in effect for all tags and cookies implemented with Google Tag Manager.

Our Website also uses software technology known as transparent GIF files (i.e. web beacons) to help us better manage content on our Website by telling us what content is effective. Transparent GIF files are tiny graphics with a unique identifier that function similar to cookies and are used to track the online actions of Internet users. Unlike cookies stored on a user's computer hard disk, transparent GIF files are invisibly embedded in websites and are about the size of the dot at the end of this sentence. We may link the information collected by the transparent GIF files to our customers' Personal Data.

The web beacon of Act-On is used for our legitimate interests in order to ensure that our website is designed to meet requirements and is continually optimised. We also use the web beacon to statistically record the use of our website and to evaluate it for the purpose of optimising our offers.

### 2. Managing cookie preferences

We use the services of OneTrust, LLC (London, UK) for the management of cookies on our Website. Our Website is configured in a way to only allow the placement of non-essential cookies if you accept their placement via our cookie banner. You have the option to accept all cookies, reject all cookies which are not necessary for the functioning of the Website, or to decide for single cookies to be in place. You can revoke your consent by following the opt-out options described below or using the respective setting option provided by OneTrust.
